Pavement Preservation Warranty work in Windsor, Shellwood, Parkmonte and Whinsenton: This project is nearly completed.

## Southern Live Oak Street-Tree removal and Replacement Project (Windsor, Meridian, Enclave, Provence and The Haven):

This project will soon come to completion. Removal and replacement of the existing Southern Live Oak trees within the District right-of-way was undertaken because the street-trees have posed a threat to damaging the District's sidewalks and roads.

#### **Swimming Pool Resurfacing:**

Resurfacing of our swimming pool is under way. We have learned that it is necessary to do some renovations on our pool deck pavers, as well. The swimming pool and pool deck will remain closed while this work is being done. We'll advise you by email when the pool is open for use.

MPIII has graciously offered the use of their pool to MPIV residents during this renovation time. Proof of MPIV residence is required. No guests are permitted.

**Community Ponds:** Beginning in May, our Aquatics Contractor will be installing new water plants in and around the perimeter of our ponds. These plants help to ensure the health of our ponds and minimize erosion. Please avoid these areas. No fishing or swimming in our CDD ponds is permitted.

## **Community Safety on our Roadways:**

The Board of Supervisors recommends that all residents who have concerns about safety issues in our Meadow Pointe IV area, such as crosswalks, the
